Although funds were sanctioned long ago, the contractor has not taken up the work seriously.</p> <p>When we contacted the Assistant Engineer, Palakkad NH Sub Division (Mr. Sunil, 8086395239), his only reply was that the contractor is not cooperating and not picking his calls. This shows a complete lack of accountability from both the contractor and the local officers.</p> <p>We request urgent intervention from higher authorities to ensure that the sanctioned project is carried out immediately.</p> <p>Sincerely, [Your Name]</p>
2	<p>Respected Minister for Public Works (PWD), Kerala,</p> <p>Respected Chief Minister of Kerala,</p> <p>The Nemmara–Olipara Road project has been sanctioned but remains incomplete. The contractor responsible is not executing the work, leaving commuters in great difficulty.</p> <p>We contacted Palakkad AE (NH Sub Division, Mr. Sunil, 8086395239), but his response was discouraging. He stated he cannot act since the contractor is not responding to his calls. Detailed content sample

Respected Minister for Public Works (PWD), Kerala,
Respected Chief Minister of Kerala,

I am writing to you with deep concern on behalf of the people of **Ayiloor and Nenmara Grama Panchayats**, regarding the condition of the **Nenmara–Olippara Road**. This 10.8 km stretch is the **only main connection to Nenmara**, and it is used daily by thousands of people from both Panchayats.

This road was sanctioned under **CRIF 2022–23**, with **₹16 crore** allotted for its renovation. The contract period was from **August 2023 to August 2024**. Even after more than one year past the completion date, the road remains incomplete and in a severely damaged state.

The sanctioned work was officially handed over to the contractor in August 2023. However, the current situation is alarming:

- The **contractor has completely failed** to carry out his responsibilities. It is very concerning that the contractor himself has admitted that he does not have the required resources to complete the work.
- The **officials in charge are not taking timely or effective action**, allowing this unacceptable delay to continue.
- It is extremely **pathetic and unacceptable** that even after funds have been **allocated and sanctioned**, the road remains broken and incomplete more than one year after the contract deadline.

The hardships faced by people are severe:

1. **Healthcare:** The nearest hospitals, both government and private, are in Nenmara. Even patients in emergencies are forced to suffer through this unsafe road.
2. **Education:** More than 10 schools, colleges, and educational institutions depend on this road. Students and teachers travel daily under unsafe and difficult conditions.

3. **Work and Livelihood:** Thousands of office-goers and daily-wage workers from **Ayiloor and Nenmara Panchayats** travel to Nenmara every day. They are forced to waste time, money, and risk their health due to this broken stretch.
4. **Transport:** Autorickshaw drivers often refuse to take trips through this road, or charge extra due to the damage caused to their vehicles. Buses, taxis, and private vehicles also face repeated breakdowns and heavy repair costs.
5. **Public Safety:** Frequent accidents, vehicle breakdowns, and health problems from dust and stagnant water are common.

Sir, this road is not just a convenience but a **lifeline** for the people of both **Ayiloor and Nenmara Grama Panchayats**. Its present condition has made daily life extremely difficult and unsafe.

We respectfully request your **urgent intervention** to:

- Ensure immediate completion of the pending road work.
- **Enquire into the reasons for this delay** and take strict action against the contractor who has failed his duty.
- Hold the responsible officials accountable for not enforcing the project timeline despite funds being available.

We write this letter with utmost respect and hope, trusting in your commitment to the welfare of the people. The situation has become unbearable, and we sincerely urge you to take immediate steps so that this long-pending road is finally completed.
